- 3. Pond updates (Walter)
  - a. Updated estimates
    - i. Pipe cleaning
      - All South, estimate for entire north side, can do job all in one day, pipe going into pond is underwater, if they can get into pipe opening at chest level don't need dive team, clear primary pipe, total on

estimate doesn't include the approx. Should be able to do it in one and and with one truck, 3k for dive team, include dive team and add 10% contingency. Will ask them to do overtime vs second day of work, we need to request this estimate by honored for 90 days.

- Cloud 9, estimate provided worst-case scenario, includes a weekly rate, but not likely to need a week of labor, the hour rate is billed at 30 hours.
